#### **BILL 124 – DECLARED UNCONSTITUTIONAL**

Unionized workers across Ontario are celebrating after a court ruled the Ford government's controversial wage restraint law -- Bill 124 – unconstitutional!

It is an important victory for Ontario workers; the Ontario Superior Court of Justice has struck down Bill 124 in its entirety. The court struck down the bill on the basis that it violates the fundamental constitutional rights to collectively bargain and to strike - constitutional rights recognized by the Supreme Court of Canada and enshrined in the Canadian Charter of Rights and Freedoms.

The bill imposed 3 years of moderation- wage and compensation freezes of 1%. This ruling means we will now be entering into bargaining on December 16<sup>th</sup> with no restrictions on wages and compensation.

We know you have questions about compensation and potential retroactivity- we are working on getting those answers. The court's ruling did not impose a remedy to the law being repealed but we know that CUPE National will be providing direction in the days to come.

Stay tuned and we will keep you updated on next steps.
